### Top Story

The Government had a comfortable victory of 60 votes to 39 in the Dáil on its proposal to suspend water charges for nine months while a commission deals with the issue. Fianna Fáil abstained, securing the Government's victory. To read more on this story, [click here](#).

Sinn Fein has accused Fianna Fail of acting in coalition with Fine Gael by abstaining in a motion to scrap water charges. The majority of people in Northern Ireland want to see the UK remaining in the EU, according to a new poll published today. The poll, conducted online by LucidTalk and published in this morning's Northern Ireland edition of the Sun newspaper, finds that 57 per cent of respondents intend to vote to remain in the EU while 35 per cent wish to leave.
