Dr. Gerhard Wahlers

Director, International Division, Konrad-Adenauer-Foundation, Berlin

Dr. Gerhard Wahlers joined the Konrad-Adenauer-Foundation as advisor in the International Cooperation Division in March 1990. Dr. Wahlers was Head of the KAS office in Jerusalem from 1994-1997 and Head of the KAS office in Washington from 1997-2003. Dr. Wahlers took up the post of Head of the International Division in 2003. Dr. Wahlers obtained his PhD in philosophy at Westfälische Wilhelms-Universität in Münster and has degrees in history, sociology and political science.

Ambassador Ortwin Hennig

Vice President and Head of Conflict Prevention Program, EASTWEST Institute

Ambassador Ortwin Hennig is the EWI Vice-President for Conflict Prevention, Former Commissioner for Conflict Prevention in the German Federal Government. In 2004 he became a Member of the Board of Directors of the International Energy Society (ISES).
