Germany decided to switch almost entirely to green energy until 2050. That way the greenhouse gases shall be reduced dramatically. Regarding the field of foreign policy, the German "Energiewende" is confronted with dramatic changes in the global energy context. While the U.S. are trying to become independent of energy imports by exploiting shale gas, global energy demand is increasingly dominated by emerging markets like China. At the same time renewable energy steadily gains importance and might be an answer to growing energy demands and the challenges posed by climate change. That creates opportunities as well as risks for Germany, which needs to be identified and addressed by a consistent foreign policy. This conference focuses on the international aspects of the "Energiewende" in a context of economic and geopolitical challenges.
