But a vast majority has confidence in the integrity, professionalism and impartiality of the judicial system. A properly working judicial system, the rule of law they are cornerstones of a working democracy. And if we want to live in a sustainable democracy we must make these cornerstones very solid and strong ones.

- The Romanian Justice system is still monitored by the European Commission under the Cooperation and Verification Mechanism. This should not last forever but the condition for its lifting is that true and irreversible progress will have been made.
- 3. As this project is of such an immense importance for the country as a whole it requires the goodwill of all those involved. Political debates especially strategic ones are controversial by nature, but those who take part should also show the will to compromise and to cooperate. Because endless debate will lose the momentum and will end up in nothing. And it should definitely not happen. So we should not have a debate for the purpose of itself, but with the objective to build a broad consensus that will go along with building broad political majorities and will lead to concrete results in a reasonable time...
