



## UGANDA LAW SOCIETY 7TH ANNUAL RULE OF LAW DAY SYNOPSIS- OCTOBER 2014

For six years now, the ULS has commemorated an annual Rule of Law week in October each year with a series of activities; culminating in an Annual Rule of Law Symposium. These activities include radio talk shows in the four regions of the country on prevailing topical Rule of Law issues and consultative meetings with key relevant stakeholders (both State and non State actors) to take stock of the status of the Rule of Law in Uganda; and to proffer strategies and solutions to uphold the same.

This year, four radio talk shows were held in the districts of Mbarara, Soroti, Gulu and Kampala respectively sensitizing the public on labour rights and various aspects pertaining to the decent work agenda in Uganda and the region. These talk shows generated debate and there were a good number of call-ins appreciating the ULS for considering this discussion on the rights and plight of workers that has been long overdue.

On **October 3, 2014**, the ULS commemorated its 7<sup>th</sup> Annual Rule of Law Day by way of:-

- a) A High Level Stakeholders' Breakfast Meeting which as always was a closed to the public and the press to enable candid discussions among key stakeholders from relevant institutions on selected topical issues. This year deliberations were held and strategies laid on the following topics:
  - Progress of the Industrial Court;
  - Human Trafficking in Uganda;
  - The National ID System;
  - Critical electoral reforms ahead of 2016;
  - The Administration of Justice Bill (a follow-up from last year).

The high level meeting was very successful as participants shared critical information and implored the ULS to use its mandate and clout to advance the necessary reforms and actions proposed.
