KEYNOTE SPEAKER – I



Dr. Surin Pitsuwan received his primary and secondary education in his home province of Nakorn Sri Thammarat, Thailand. He became a Member of Parliament of Thailand in 1986, and has served in the same constituency for seven consecutive terms. During this period, he was appointed as secretary to the Speaker of the House of Representatives in 1986. Subsequent appointments were as assistant secretary to the Minister of Interior in 1988 and as Deputy Foreign Affairs Minister from 1992-1995. He was appointed as the Minister of Foreign Affairs from 1992-2001. A graduate in political science from Claremont Men's College in California, Dr. Surin holds a Ph. D. from Harvard University.

He also spent a year and a half studying Arabic and conducting his research at the American University in Cairo, 1975-1977, while concurrently a fellow at the Higher Council for Islamic Research, Cairo, Egypt.

Dr. Surin became the 12th Secretary-General of ASEAN (2008 – 2012). He contributed much to the development of ASEAN not only when he was its Secretary-General but also when he was the Foreign Minister of Thailand. Two of his most recognized accomplishments in dealing with ASEAN affairs were [1] first, spearheading the Asian countries to help restore law and order in East Timor during the violent uprising in the aftermath of the Referendum in August 1999, and [2] second, leading the ASEAN Member States and the United Nations and other international institutions such as the World Bank, Asian Development Bank and various other International NGOs to enter Myanmar to rescue that country from the catastrophe of Cyclone Nargis in May 2008 and remained there until the mission was accomplished in December 2010.

After his term as Secretary General of ASEAN, Dr. Surin has been appointed Professor Emeritus at Thammasat University and also an Honorary Advisor and Distinguished Visiting Fellow at King Prajadhipok Institute, an academic affiliation of the Thai Parliament.

KEYNOTE SPEAKER – II



Rizal G. Buendia, Ph. D. is Independent Consultant/Researcher in Southeast Asian Politics and International Development based in London, United Kingdom. He is former Teaching Fellow in Politics at the Department of Politics and International Studies and the Department of Development Studies, School of Oriental and African Studies (SOAS), University of London and Chair of the Political Science Department, De La Salle University-Manila.

He authored the books *The Politics of the Bangsamoro Basic Law* (2015) and *Ethnicity and Subnationalist Independence Movements in the Philippines and Indonesia: Implications for Regional Security* (2002), published articles on the ASEAN, multiculturalism, peace and conflict, ethnopolitics, secessionism, human rights, governance, security, plural democracy, social development, and development administration in refereed international academic journals and book chapters. Currently, he is working on commissioned researches on the ASEAN Political-Security Blueprint and the Skills Mobility under the ASEAN Economic Community.

He served as consultant in various international development agencies, like the World Bank (WB), Asian Development Bank (ADB), United States Agency for International Development (USAID), United Nations Development Program (UNDP), ASEAN Governance Innovations Network-Institute of Governance (CAGIN-IOG), Canada International Development Agency (CIDA) and the International Development Research Centre (IDRC) among others.

He earned his PhD in Political Science at the National University of Singapore (NUS. He obtained his Master of Arts in Public Administration (MPA) from the University of the Philippines-Diliman (National College of Public Administration and Governance [NCPAG]).

Presently, he is a member of the International Editorial Board of the *Asian Journal of Criminology* (Melbourne, Australia), Founding Member of the Asian Criminological Society (Beijing, China), and former Editor in Chief of the *Asia Pacific Social Science Journal*. He is also member of the Association for Asian Studies (AAS) and the *Phi Gamma Mu* Honor Society.

Dr. Mohammad Iqbal Ahnaf is a faculty member at the Centre for Religious and Cross-cultural Studies (CRCS) Graduate School, Gadjah Mada University. He earned a Master degree in conflict transformation at the Centre for Justice and Peacebuilding, Eastern Mennonite University (USA) and Ph.D in Strategic Studies, Victoria University of Wellington (New Zealand).

He was also appointed as a country coordinator of *Democracy (V-Dem)*, an international research collaboration for creating an alternative democracy index co-hosted by the Department of Political Science at the University of Gothenburg, Sweden; and the Kellogg Institute at the University of Notre Dame, USA.

Dr. Mohd Sani Badron is a Principal Fellow at the Centre of Economics and Social Studies, Institute of Islamic Understanding Malaysia (IKIM). He was conferred Bachelor of Laws by the International Islamic University of Malaysia (IIUM), and M.A. as well as Ph.D. in Islamic Thought by the International Institute of Islamic Thought and Civilization (ISTAC).

He joined ISTAC as Research Fellow (1993-2003), and then IIUM as Lecturer at the Department of Theology, Philosophy and Comparative Religions (2003-2006).



Dato' Emeritus Professor Osman Bakar, who earned a doctorate in Islamic philosophy from Temple University, Philadelphia is currently Distinguished Professor and Director of Sultan Omar Ali Saifuddien Centre for Islamic Studies (SOASCIS) at Universiti Brunei Darussalam.

He was formerly Deputy Vice Chancellor (Academic & Research) of University of Malaya, Malaysia Chair of Southeast Asian Islam at the Prince Talal al-Waleed Center for Muslim-Christian Understanding, Georgetown University, Washington DC and Deputy Chief Executive Officer (CEO), International Institute of Advanced Islamic Studies, Malaysia (IAIS).

An Emeritus Professor of Philosophy of Science at the Department of Science and Technology Studies, University of Malaya, he was also the founder of the University's Center for Civilizational Dialogue (1996). In 1994 he was made a Dato' by HH the Sultan of Pahang and in 2000 a Datuk by the Malaysian King.

Dr. Bakar is an author of 20 books and more than 300 articles on various aspects of Islamic thought and civilization, particularly Islamic science and philosophy and Islam in Southeast Asia. He was a member of the Council of 100 Leaders of the West-Islamic World Initiative for Dialogue founded by the World Economic Forum, Davos, Switzerland.

His two most well-known books, *Classification of Knowledge in Islam* and *Tawhid and Science* have been translated into numerous languages. His latest books are *Islamic Civilization and the Modern World: Thematic Essays* (2014), *Quranic Pictures of the Cosmos: The Scriptural Foundation of Islamic Cosmology* (2016), and *Islamic Perspectives on Science and Technology* (co-editor, 2016).

He has been Professor of Sociology, Chulalongkorn University, since 2009.

His publications include: *Confronting Cultural Globalization: A New Framework for Policy*. Office of Contemporary Arts and Culture (in Thai, 2004); *The Provinciality of Globalization: A Thai Perspective* (2004); *Rural Livelihoods and Human Insecurities in Globalizing Asian Economies* (2007); *Sociology of Tsunami: Coping with the Disaster* (in Thai, 2007), and *Health Governance and Institutional Learning Capacities in the New Context* (HSRI 2014).

He has been active in civil society movements and democratization issues, he is Chairperson of NGOs, namely, *Labor Rights Promotion Network*, and *Ecological Alert and Recovery Thailand (EARTH)* Foundation.

Triggered by increasing violence in southern most provinces of Thailand, he joined campaigns to change government policies under former prime minister Mr. Thaksin Shinawatra. Consequently, in 2004, he was a member and joint secretary of National Reconciliation Commission (NRC) chaired by Mr. Anand Panyarchun, former Prime Minister of Thailand. Since 2010, he is the Director, Center for Peace and Conflict Studies, Chulalongkorn University.
