## "How Will Coronavirus Reshape Democracy and Governance Globally?"

The authors suggest in this commentary that the coronavirus pandemic will likely have a transformative impact on multiple dimensions of democratic politics and on governance more broadly. They state that "...the new coronavirus pandemic is not only wreaking destruction on public health and the global economy but disrupting democracy and governance worldwide. Global leaders should prepare to respond quickly".

# "Stretching the International Order to its Breaking Point"

The author argues that the greatest error geopolitical analysts can make is believing that the crisis will be over in three to four months. In a long crisis, he lays out how all "countries will emerge profoundly changed... [and will] expose which countries are competent." In case of the U.S., he points out that "President Trump is singularly illequipped to handle the pandemic." Praise in handling the pandemic is given to a few countries, including Germany "in showing signs of competency, particularly in testing."

#### "An Eroding European Union"

Heather Conley predicts that the coronavirus will alter the European Union considerably in her analysis for the Center for Strategic and International Studies. Conley examines the political and economic impact of the pandemic on European countries and the pressure on democratic structures which are in "decline" in several of the EU member countries. Conley says: "The economic divisions between the prosperous North and the poorer South are put in sharp contrast." Conley envisions two very different paths forward.

#### "Coronavirus Lessons from New York and San Francisco"

Indermit Gill, Non-Resident Sr. Fellow at the Brookings Institution

Indermit Gill, Non-Resident Sr. Fellow at the Brookings Institution, Professor at Duke University and former Director for Development Policy at the World Bank, compares recent developments in San Francisco and New York with regard to COVID-19. He suggests that California has been the best performer among U.S. states that have had at least ten COVID-19 deaths; New York has been the worst. But these are big states and they differ in many aspects, writes Prof. Gill. He emphazises that it is more informative to compare cities of similar size but have fared differently in dealing with the disease. Two obvious candidates are New York City and San Francisco, the most densely populated cities in these states and the two densest large cities in the U.S. Here is his blogpost:

#### "COVID-19: China Medical Supply Chains and Broader Trade Issues"

The report outlines the ways in which the U.S. economy depends on manufacturing and supply chains based in China in light of the outbreak of Covid-19. It aims to assess current developments and to identify immediate and longer range China trade issues for Congress. Among the considerations advanced are for Congress are to incentivize additional production of health supplies, diversify production, address other supply chain dependencies (e.g. microelectronics), fill information and data gaps, and promote U.S. leadership on global health and trade issues.

### "Younger Americans View Coronavirus Outbreak More as a Major Threat to Finances Than Health"

A survey conducted in late March finds that fewer Americans view the outbreak of COVID-19 as a threat to their health than to their finances, especially those under age 30. Aside from the age gap in threat perception of the outbreak of the coronavirus, the study also finds noticeable partisan differences. Democrats and Democratic- leaners perceive the coronavirus outbreak to be a greater threat to their personal health and finances than Republicans or Republican-leaners. This also affects attitudes towards social distancing along party lines, gender, as well as other demographic factors.

## "How to Protect Both Public Health and Privacy - Fighting COVID-19 Does Not Have to Mean Abandoning the Right to Privacy"

Allie Funk writes that governments all over the world have been experimenting with new initiatives using massive amounts of data "to monitor infections, trace infected people's contacts, ensure quarantine compliance, and map the spread of the disease." While these efforts may help save lives, the author also identifies the risk that new health-related monitoring programs might create pervasive surveillance, possibly violating individual rights.

Funk advocates testing such monitoring programs for necessity and proportionality, oversight, transparency, as well as sunsetting and limiting data collection, access, and use.

## "Digital Policy for Physical Distancing: 28 Stimulus Proposals That Will Pay Long-Term Dividends"

Robert D. Atkinson, President; Doug Brake, Director, Broadband and Spectrum Policy; Daniel Castro, Vice President and Director, Center for Data Innovation; Stephen Ezell, Vice President, Global Innovation Policy According to the authors, "the COVID-19 pandemic has revealed gaps in society's digital readiness for social distancing. If policymakers seize the opportunity to address these gaps, they can make it easier to manage the next pandemic while providing significant long-term social and economic benefits."

To this end, the report identifies several recommendations for government, including the development of foundational digital platforms (universal broadband, 5G, digital IDs), the increased funding of key technologies (robotics, autonomous vehicles, 3D printing, Al, blockchain, IOT, and facial recognition), the support of digital transformation for remote activity in key sectors, and to invest in digital resiliency to better prepare for future pandemics.

### "As Newsrooms Face Coronavirus-Related Cuts, 54% of Americans Rate Media's Response to the Outbreak Positively"

The majority of Americans rate the media's coverage of the coronavirus pandemic positively, finds this Pew Research Center study. Although opinions vary depending on the news sources Americans consume, with network TV and print media receiving the highest marks while social media sources are rated poorly. The author finds that at this time when the public's interest in news coverage is very high, many news organizations are facing intense financial pressure and have announced furloughs and layoffs.

Henry Kissinger urges the U.S. to "protect its citizens from the disease while starting the urgent work of planning for a new epoch." Kissinger lays out three steps for leaders to build for the future: (1) Shore up global resilience to infectious disease; (2) address the crisis in the world economy; and (3) safeguard the principles of the liberal world order.

#### "The Technology That Could Free America From Quarantine"

While admitting that the technology and privacy challenges of tracing will be complex, and "could normalize a level of surveillance," Thompson argues that "our best hope in the fight against the coronavirus is to play a game of sophisticated Whack-a-Mole that often goes by the name of "test and trace," using GPS, Bluetooth and cellular data shed by millions of mobile phones. Thompson asserts that test and trace seemed to work, pointing to the examples of Singapore and South Korea, who had reduced COVID-19 deaths rather successfully. However, the data generated by tracing apps would also be "tantalizing for powerhungry governments and data-hungry corporations to monopolize."
