

## Information in accordance with Article 13 of the EU General Data Protection Regulation (GDPR)

This document provides information on how the Konrad-Adenauer-Stiftung e.V. processes your personal data:

### Data controller and contact details for the data protection officer

The data controller within the meaning of the data protection legislation, in particular the EU General Data Protection Regulation (GDPR), is the Konrad-Adenauer-Stiftung e.V., Klingelhöferstraße 23, 10785 Berlin.

### Data categories

The categories of personal data processed include the following data: Email address, your first name, surname, username and password. Information on a voluntary basis: if applicable, the language you have chosen, your second name and date of birth.

Furthermore, we process the following information in order to document the proof of consent:

- Date and time of the respective access and password change if necessary
- IP address of the user's Internet connection

Your personal data is generally collected directly from you when you register.

### Purposes and legal basis of data processing

We process personal data pursuant to Article 4 GDPR in accordance with the provisions of the EU General Data Protection Regulation and the Federal Data Protection Act (BDSG - new version):

The purpose of processing your data is to provide you with the comment function on our website.

By registering for the comment function, you consent to the processing of your data (Article 6(1)(a) GDPR. Registration is carried out using the double opt-in procedure.

### Recipients of personal data

At the Konrad-Adenauer-Stiftung e.V., personal data is collected, processed and stored by the departments that need this data to process your registration.

Processors who we engage may also receive personal data for these purposes, provided they can guarantee compliance with the requirements of the GDPR and the BDSG.

The external contractors are appointed within the framework of our legitimate interests in accordance with Article 6 (1) (f) GDPR and on the basis of contract processing agreements as per Article 28 GDPR.

### **Transfer of data to a third country**

Data is not transferred to countries outside of the EU/EEA (known as third countries).

### **Duration of processing**

Your personal data will be processed/stored by the Konrad-Adenauer-Stiftung e.V. for as long as required to fulfil the purposes stated above and to comply with any applicable legal provisions and the statutory retention periods for the respective task fulfilment.

### **Your rights**

You can exercise the following rights using the contact details given above:

- Information regarding your data that we hold and its processing
- Rectification of incorrect personal data
- Deletion of your personal data that we hold
- Restriction of data processing, if we are not yet permitted to delete your data due to statutory obligations
- Objection against our processing of your data
- Data portability

You can withdraw your consent at any time with future effect by sending an informal message to us by email ([redaktion@kas.de](mailto:redaktion@kas.de)). Please note that this withdrawal will only have future effect. Withdrawing your consent does not affect the legality of any processing that has taken place on the basis of your consent until its withdrawal.

If you exercise any of your rights specified above, the Konrad-Adenauer-Stiftung e. V. will check whether the legal requirements for this have been met.

You may lodge a complaint before the supervisory authority under whose jurisdiction you fall at any time.

### **Provision of your data**

You are not obliged to provide your personal data. However, the non-provision of this information means that we cannot provide you with the possibility of comment function.
