## FW de Klerk

During his presidency from September 1989 until May 1994, FW de Klerk dismantled apartheid and initiated and presided over the inclusive negotiations that led to the adoption of South Africa's first fully democratic Constitution in December 1993. Also in 1993, he was awarded the Nobel Peace Prize, together with Nelson Mandela. After the election on 27 April 1994, Mr De Klerk served as one of South Africa's two

Executive Deputy Presidents until 1996, when his party withdrew from the Government of National Unity. He retired from active politics in September 1997. In 1999 he published his autobiography, *The Last Trek - A New Beginning* and established the FW de Klerk Foundation. The Foundation upholds the Constitution through the work of its Centre for Constitutional Rights and works for positive relations in multi-cultural societies through the work of its Centre for Unity in Diversity. Mr De Klerk is also the Chairman of the Global Leadership Foundation, established in 2004, whose panel of former presidents, prime ministers and statesmen provides discreet advice to heads of government on issues that concern them.

Gedurende sy presidentskap tussen September 1989 en Mei 1994 het FW de Klerk apartheid beëindig en die inklusiewe onderhandelinge van stapel gestuur en bestuur wat in Desember 1993 gelei het tot die aanvaarding van Suid-Afrika se eerste ten volle demokratiese Grondwet. Ná die verkiesing op 27 April 1994 het hy tot Junie 1996, toe sy party aan die regering van nasionale eenheid onttrek het, as een van Suid-Afrika se twee uitvoerende adjunkpresidentie gedien. Hy het in September 1997 uit die aktiewe politiek getree. In 1999 het sy outobiografie, *Die Laaste Trek - 'n Nuwe Begin*, verskyn en in dieselfde jaar het hy die FW de Klerk Stigting geloods. Die Stigting onderskraag die Grondwet deur die werksaamhede van sy Sentrum vir Grondwetlike Regte en bevorder positiewe verhoudings binne multikulturele gemeenskappe deur die werksaamhede van sy Sentrum vir Eenheid in Diversiteit. Mnr De Klerk is ook voorsitter van die Global Leadership Foundation wat in 2004 gestig is. Die GLF se paneel van voormalige presidente, eerste ministers en staatsmanne verskaf vertroulike en diskrete advies aan staatshoofde oor die uitdagings wat hulle moet hanteer.



## Stefan Friedrich

Dr Stefan Friedrich, born 1965, is a senior staff member of the Konrad-Adenauer-Stiftung (KAS). KAS is a German political foundation with 16 offices in Germany and a large set of international offices in charge of over 200 projects in more than 120 countries. At home, as well as abroad, KAS' civic education programmes aim at promoting freedom and liberty, peace, and justice. Dr Friedrich's areas of expertise include the United

Nations, multilateral development policy, foreign and security policy. As a sinologist and political scientist, his research interests are primarily in the field of Chinese foreign and domestic policy, as well as general topics of developments in Asia. He is fluent in English, French and Chinese and has published widely on China's foreign relations. Dr Friedrich holds an MA (1994) and PhD (1999) of the University of Heidelberg. His studies in Modern Sinology and Political Sciences included extended research periods at several universities - in Shanghai (Fudan), Paris (EHESS) and London (SOAS). From March 2005 to August 2012, he was Head of the Asia and Pacific Team of KAS and, from 2001 to the beginning of 2005, Head of the KAS office in Shanghai. Thereafter, he was the founding director of the New York office for two years and, from September 2012 to July 2016, the Political Dialogue and Analysis team, the KAS Think Tank on international affairs. Dr Friedrich currently leads the Sub-Saharan Africa team.

Dr Stefan Friedrich, gebore in 1965, is 'n senior personeellid van die Konrad-Adenauer-Stiftung (KAS). KAS is 'n Duitse politieke stigting met 16 kantore in Duitsland en 'n groot aantal internasionale kantore in beheer van meer as 200 projekte in meer as 120 lande. Tuis sowel as in die buiteland beoog KAS se burgerlike onderrigprogramme om vryheid, vrede en geregtigheid te bevorder. Dr Friedrich se gebied van kundigheid sluit in die Verenigde Nasies, multilaterale ontwikkelingsbeleid, buitelandse en sekuriteitsbeleid.

As sinoloog en politieke wetenskaplike is sy navorsingsbelange hoofsaaklik op die gebied van Chinese buitelandse en binnelandse beleid gefokus, sowel as algemene onderwerpe van ontwikkelings in Asië. Hy is vlot in Engels, Frans en Chinees en het wyd gepubliseer oor China se buitelandse betrekkinge. Dr Friedrich het 'n MA (1994) en PhD (1999) van die Universiteit van Heidelberg behaal. Sy studies in Moderne Sinologie en Politieke Wetenskappe het uitgebreide navorsingsperiodes by verskeie universiteite ingesluit - in Sjanghai (Fudan), Parys (EHESS) en Londen (SOAS). Van Maart 2005 tot Augustus 2012 was hy hoof van die Asië- en Stille Oseaanspan van KAS en vanaf 2001 tot die begin van 2005, hoof van die KAS-kantoor in Sjanghai. Daarna was hy vir twee jaar die stigtersdirekteur van die New York-kantoor en van September 2012 tot Julie 2016 van die Politieke Dialoog- en Analise-span, die KAS Think Tank oor internasionale sake. Dr Friedrich lei tans die Afrika-span van Afrika suid van die Sahara.



## Helen Zille

Helen Zille is the former Premier of the Western Cape. She was elected to office by the Provincial Parliament on 6 May 2009, and reelected after the May 2014 general elections, her 2nd term of office came to an end on the 21st of May 2019. She was educated at Johannesburg's St Mary's School, Waverley and the University of the Witwatersrand, where she obtained a Bachelor of Arts degree. Before Helen Zille began her career

in politics she worked as a political correspondent for the *Rand Daily Mail*, where she covered key political stories, such as the death, in police custody, of black consciousness activist Steve Biko. In 1977 she was able to prove that Biko had been tortured to death and that the official version of the story, which claimed he had died of natural causes, was false. From the 1980s onward she became involved in NGOs and activist organisations, including the Open Society Foundation, the Independent Media Diversity Trust, and the Black Sash. She also campaigned against vigilantism and repression in the Cape Town townships, and was part of the peace movement that worked to bring warring factions in Crossroads together. She joined the former Democratic Party in the mid 1990s, where she was asked to reformulate the party's education policy and stand as a candidate on its election list for the Western Cape legislature. She also acted as Technical Adviser to the party at CODESA in the early 1990s. Helen was elected to the provincial parliament in the 1999 general election under the banner of the Democratic Alliance. From 1999 to 2001 she served as Minister of Education in the Western Cape Province. When the ANC gained power in 2001 she became Leader of the Opposition in the Western Cape legislature, where she remained until she was elected as a member of the National Parliament in 2004. As a Democratic Alliance MP she served on the Portfolio Committee on Education, and acted as the DA's National Spokesperson. Her constituency included Langa, Gugulethu and Khayelitsha. On 15 March 2006 she was elected as Mayor of Cape Town, and resigned from Parliament. Two years later, in 2008, she was voted World Mayor in a poll of over 800 cities around the world conducted by global think tank World Mayors. On 6 May 2007 she was elected as the Leader of the Democratic Alliance, and was re-elected in 2012. Her term as DA leader ended in May 2015. In 2016, Helen released her autobiography *Not Without A Fight*. The *City Press* described it as the 'Nonfiction book of the year'.

Helen Zille is die voormalige premier van die Wes-Kaap. Sy is op 6 Mei 2009 deur tot provinsiale parlement verkies, en sy is na die algemene verkiesing in Mei 2014 herverkies. Haar tweede ampstermyn het op 21 Mei 2019 tot 'n einde gekom. Sy het haar opvoeding aan die Johannesburgse St Mary's School, Waverley en aan die Universiteit van die Witwatersrand ontvang, waar sy 'n BA-graad behaal het. Voordat Helen Zille haar loopbaan in die politiek begin het, het sy as politieke correspondent vir die *Rand Daily Mail* gewerk, waar sy belangrike politieke stories gedek het, soos die dood van die swartbewussynsaktivis Steve Biko toe hy onder polisiebewaking was. In 1977 kon sy bewys dat Biko dood gemartel is en dat die amptelike weergawe van die storie, wat beweer het dat hy van natuurlike oorsake dood is, vals was. In die tagtigerjare het sy betrokke geraak by NRO's en aktivistiese organisasies, waaronder die Open Society Foundation, die Independent Media Diversity Trust, en Black Sash. Sy het ook teen vigilantisme en onderdrukking in die Kaapse townships geveg, en was deel van die vredesbeweging wat

saamgewerk het om strydende faksies bymekaar te bring. Sy het in die middel van die 1990s by die voormalige Demokratiese Party aangesluit waar sy gevra is om die party se onderwysbeleid te herformuleer en as kandidaat op sy verkiesingslys vir die Wes-Kaapse Wetgewer te staan. Sy het ook in die vroeë 1990s as tegniese adviseur van die party by KODESA opgetree. Helen is in die 1999 algemene verkiesing onder die vaandel van die Demokratiese Alliansie tot die provinsiale parlement verkies. Van 1999 tot 2001 het sy as Minister van Onderwys in die Wes-Kaap gedien. Toe die ANC in 2001 aan bewind gekom het, het sy Leier van die Oposisie in die Wes-Kaapse Wetgewer geword, waar sy gebly het totdat sy in 2004 as 'n lid van die Nasionale Parlement verkies is. As 'n LP van die Demokratiese Alliansie het sy op die Portefeuljekomitee oor Onderwys gedien en opgetree as die DA se nasionale woordvoerder. Haar kiesafdeling sluit in Langa, Gugulethu en Khayelitsha. Op 15 Maart 2006 is sy as burgemeester van Kaapstad verkies, en het sy uit die Parlement bedank. Twee jaar later, in 2008, is sy as die beste burgemeester ter wêreld aangewys in 'n meningspeiling van meer as 800 stede wat deur World Mayors uitgevoer is. In 2016 het Helen haar outobiografie, *Nie Sonder 'n Stryd nie*, bekendgestel. *City Press* het dit as die 'nie-fiksie boek van die jaar' aangewys.



## Robin Renwick

Lord Renwick of Clifton was British Ambassador to South Africa from 1987 to 1981 and to the United States from 1981 to 1995. As Prime Minister Thatcher's representative in South Africa, he succeeded in establishing a close relationship with both President De Klerk and Nelson Mandela. After leaving the Foreign Service, he became a Director of British Airways, BHP Billiton, SABMiller, Richemont and various

other companies. He is the author of *The End of Apartheid: Diary of a Revolution*, *Helen Suzman: Bright Star in a Dark Chamber*, *How to Steal a Country* and *Not Quite a Diplomat* (Memoir).

Lord Renwick of Clifton was van 1987 tot 1981 die Britse ambassadeur van Suid-Afrika en van die Verenigde Nasies van 1981 tot 1995. As Eerste Minister Thatcher se verteenwoordiger in Suid-Afrika het hy daarin geslaag om 'n noue verhouding met beide president De Klerk en Nelson Mandela te vestig. Nadat hy die Buitelandse Diens verlaat het, het hy 'n direkteur van British Airways, BHP Billiton, SABMiller, Richemont en verskeie ander maatskappye geword. Hy is die skrywer van *The End of Apartheid: Diary of a Revolution*, *Helen Suzman: Bright Star in a Dark Chamber*, *How to Steal a Country* en *Not Quite a Diplomat* (Memoir).
