11:00 am	Afghanistan 20 years after 9/11: What next at the Hindu Kush? The engagement in Afghanistan shaped the German debate on security policy like no other military mission. After almost 20 years at the Hindu Kush, the situation on the ground is disappointing and inner-Afghan peace talks have stalled. While the Istanbul Conference is supposed to give fresh impetus to the peace process, the US – and thus all NATO allies – have decided to withdraw their military forces from Afghanistan before the 20 th anniversary of the 9/11 terrorist attacks. With the end of the deployment to Afghanistan nearing, the question of how to assess the mission as a whole arises. The engagement is a formative event that holds implications for German security policy as a whole. Which of its objectives has the international mission in Afghanistan reached in almost 20 years? What does the troop withdrawal mean for the political and military situation on the ground and for the fight against international terrorism?
