Cambodia is located in a natural disaster prone region. Extreme events like storms, floods and typhoons regularly affect the country, especially during the monsoon period (June to November). The phenomena El Nino and La Nina have been also intensifying the frequency and intensity of severe floods and droughts. Unfortunately, climate change will increase the vulnerability of the country even more to extreme natural events. According to scientific research Cambodia is in the eighth position in a world ranking that assesses the countries most susceptible to natural disasters and climate change¹. Despite being a negligible emitter of greenhouse gases in the atmosphere (only 0,29 tonnes of carbon dioxide per capita per year) the country will suffer the consequences of global warming caused by excessive emission from other countries.

According to the Cambodian National Committee for Disaster Management 85 per cent of the land of the country lies within the lower Mekong basin and studies show that the Mekong River faces escalating risks of mass flooding if climate change follows current scientific predictions. In the past mass flooding used to hit the country about once a decade but recently this kind of climatic phenomenon has become an almost annual problem. In 2009 Cambodia was hit by Typhoon Ketsana, which killed 43 people and displaced tens of thousands of families. In 2011 intense rains - the worse in more than one decade - caused the death of 250 people, left thousands houses destroyed and affected more than 10 per cent of the country's crops (especially rice paddy fields). Currently it is estimated that 70 percent of losses in agricultural productivity in the country result from flooding. Climate change threatens to raise this number even more. It is expected that due to climate change the country will experience more severe water scarcity and more frequent floods, resulting in crop failures and food shortages. In addition climate change will accelerate loss of biodiversity and affect entire ecosystems. It will also lead to a rise in sea levels, which will affect coastal communities, leading to increasing internal migration. Moreover, higher temperatures and humidity will create conditions for increased incidence of malaria and dengue fever.

In spite of its limited resources the Cambodian government has been making visible efforts to improve the country's resilience to climate change. In 1995, Cambodia ratified the UN Framework Convention on Climate Change (UNFCCC) and in 2002 signed the Kyoto Protocol. In 2006 the National Climate Change Committee (NCCC) was established, which comprises representatives of 19 ministries and government agencies. It is assisted by the Climate Change Department within the Ministry of Environment.

In October 2006 the National Adaptation Programme of Action to Climate Change (NAPA) was approved by the Cambodian Council of Ministers and submitted to the UNFCCC in 2007. The aim of the programme was to "provide a framework to guide the coordination and implementation of adaptation initiatives through a participatory approach and build synergies with other relevant environment and development programmes". The programme was elaborated in alignment with Cambodia's National Strategic Development Plan 2006-2010 (NSDP). More recently, climate change was recognised as one of the cross-cutting issues (with gender and disaster risk management) in the National Strategic Development Plan 2014-2018. In November 2013 the Cambodian government launched its first Cambodia Climate Change Strategic Plan 2014-2023 (CCCSP). The strategic plan aims at building synergies among existing government policies and at ensuring strategic cohesion to address issues like climate change adaptation, GHG mitigation and low-carbon development. The two main goals of the government's policy are to reduce Cambodia's vulnerability to climate change impacts and operate a shift towards a green development path by promoting low carbon development and technologies. Some of the strategic objectives of the CCCSP are: to ensure climate resilience of critical ecosystems (Tonle Sap Lake, Mekong River, coastal ecosystems, highlands etc), biodiversity, protected areas and cultural heritage sites; to

promote low-carbon planning and technologies to support sustainable development of the country; to improve capacities, knowledge and awareness for climate change responses; to strengthen institutions and coordination frameworks for national climate change response; to promote adaptive social protection and participatory approaches in reducing loss and damage.

In 2007 the European Commission launched the Global Climate Change Alliance, a platform for dialogue and exchange of experience between the European Union and developing countries – especially those most vulnerable – on climate change. Through this initiative the Commission provides financial and technical support to partner countries in their efforts to integrate climate change into their development policies. Cambodia was selected as a pilot country in this programme, which is supported by the United Nations Development Program (UNDP). In this context, in October 2009 the National Climate Change Committee organised Cambodia's first National Forum on Climate Change, at which the Cambodia Climate Change Alliance (CCCA) was announced. The CCCA – formally launched in February 2010 – "aims at creating the enabling conditions required for Cambodia to respond to the challenges and opportunities posed by Climate Change". Its prime objective is "to strengthen the capacity of the NCCC to fulfil its mandate to address climate change and to enable line ministries and CSOs to implement priority climate change actions". The project co-financed by the European Union is expected to end in June 2014.

The Multinational Development Policy Dialogue of Konrad-Adenauer-Stiftung would like to support the development of resilience strategies to climate change in Cambodia. In this context, it organises the dialogue programme "Climate Change Adaptation: Improving the Local Resilience Strategies of Cambodian Provinces and Local Communities" with the aim to present to a delegation of Cambodian local politicians some technical and administrative resilience strategies to deal with climate change adaptation at community level. The delegation will establish contacts with European communities in Germany and Poland which are confronted with similar problems associated with climate change and will exchange knowledge on best practices. The members of the delegation will also have the opportunity to meet representatives from the European Institutions and be informed about funding opportunities for projects in the area of climate change adaptation.
