Introduction:

The “I Seminar on Evidence-based Public Policies in the Brazilian Criminal Justice System: Building Bridges between Universities, Police, Courts and Public Administrations” launches a new space for scientific debate and public policy discussions in Brazil about the evidence based movement in the Criminal Justice System (CJS): public security, criminal justice and trial courts or execution of prison sentences. In Sherman's¹ words, “evidence-based policing is the use of the best available [scientific] research data on the results of police work to implement guidelines and evaluate agencies, units and police officers. ... it uses research to guide the practice and evaluate professionals ... [and uses] the best evidence to shape the best practices.” According to Petrosino and Boruch², in general, an evidence-based public policy for criminal justice is the adoption of policies, practices and programs that have proven effective in previous evaluation studies, usually rigorous randomized controlled trials (RCTs) or high quality quasi-experiments.

In this sense, the importance given to the collection and systematization of scientific evidence, to the multi and interdisciplinary approach (criminology, sociology, psychology, geography, economics, architecture, epidemiology, computer sciences, legal sciences, statistics, mathematics, engineering and biology, among others), the use of counterfactual assessment methodologies, the search for validity, reproducibility and replicability, and the synergy resulting from the collaboration between scientists, researchers, police officers, judges, prosecutors, public defenders, prison officers and managers define this new scientific paradigm. The time has come for Governments (federal, state and municipal) to incorporate this perspective in their management, in the expectation that their challenges regarding the CJS (high prevalence of interpersonal violence, homicide and femicide, expressive drug & arms trafficking and smuggling, feeling of insecurity in public and private spaces, endemic corruption, sluggishness,

inequality of access to justice, significant criminal recidivism, unstructured prison system, reduced re-socialization of prisoners, among others) are dealt with more effectively and efficiently.

Methodology:

The Seminar will be held entirely online. The program has 12 (twelve) 40-minute presentations distributed in 4 (four) thematic panels: Sub-Theme 1 Public Policies based on Evidence in the Criminal Justice System - PPbE: Meaning, Scope and Feasibility of a “New” Paradigm; Sub-Theme 2 The Production of Scientific Evidence for PPbE; Sub-Theme 3 Analysis, Implementation and Assessment of PPbE; and Sub-Theme 4 Building Bridges: PPbE Experiences in the Brazilian Police. There will also be a special session with Prof. Spencer Chainey, from the Jill Dando Institute of Security and Crime Science, University College London, United Kingdom. The online transmission will be held on the Zoom platform and will have simultaneous translation Portuguese/English and English/Portuguese.

Target Audience:

The Seminar is aimed at scientists, researchers, university professors, police officers, judges, prosecutors, public defenders, prison officers, public managers in the criminal justice area (Public Security, Criminal Justice and Trial Courts or Prison Sentence Execution), representatives from international and national organizations, undergraduate and graduate students in areas related to the seminar’s topics and other professionals interested, according to availability of spots.
