2nd EFFL Summer Academy on Global Food Law & Policy

26–30 July 2010 Villa La Collina Cadenabbia – Lake Como, Italy







1. INTRODUCTION

The 2nd EFFL Summer Academy on Global Food Law & Policy will offer scientific reflection and discourse on key legal and policy issues in European and international food law as well as current information and updates on the latest developments. This will be achieved by means of a dynamic, informal and highly interactive five-day programme including lectures, presentations, discussion groups and social activities. The faculty of the academy consists of food experts coming from relevant authorities, European and US institutions, academia, industry and legal practice.



Alberto Alemanno, Professor of Law at HEC Paris, is the academic director of the summer academy. Barbara Klaus, a Milan-based international food lawyer, supports him in her position as managing editor of the European Food and Feed Law Review (EFFL), the leading academic journal in EU food law. The event is promoted and organised by Lexxion, the publisher of EFFL.

The academy will take place from Monday, 26 July, to Friday, 30 July, at the Villa La Collina. This historical venue offers a most impressive mountain panorama and overlooks beautiful Lake Como, Italy.

2. OBJECTIVES

The academy aims to contribute to the field of food safety in Europe – and beyond – by offering an innovative and

interdisciplinary approach to the study of this discipline. During the annual five-day course emphasis is placed on understanding the most difficult and controversial aspects of food law.

The goal of the academy is to engage lawyers, policy makers, scientists and academics with both traditional and emerging areas of food law and policy by following an innovative and interdisciplinary approach. Its programme offers an intensive exposure to practical research by relying on case studies and brain storming sessions. In order to achieve this all lecturers – each of them dedicated and enthusiastic about his/her field of expertise – are committed to use the latest research questions by always keeping an eye on real life scenarios.

3. STRUCTURE

The EFFL Summer Academy has an academic programme stretching over a period of five days, with the option to arrive one day earlier and stay over the final weekend. Each day a morning and an afternoon session is scheduled offering ample time for informal exchange and discussions during the lunch and coffee breaks.

During the morning and the afternoon sessions a lecturer introduces a topic theoretically, before turning to the empirical applications. There is always sufficient time for

Q&As and the lecturers may decide to change this structure if appropriate. Depending on the lecturer's availability, individual meetings may be scheduled between the formal teaching sessions.

Alongside the academic sessions social activities are planned on a voluntary basis.

4. ACADEMIC PROGRAMME

After refreshing the participants' knowledge of the main principles of national and international food regulation the programme will start off by contextualising food law and policy within the broader context of the WTO agreements and providing an in-depth analysis of the growing international dimension of food safety regulation. A session dealing with the state of play of EU food law will be given by analysing the latest and most controversial developments. An entire session will be devoted to the last frontiers of EU food regulation (i.e the safety and claims of botanicals). Two sessions will deal with both the institutional (EFSA) and the industry perspective of European food law. Another important lecture will focus on the enforcement side of European food regulation by discussing the official controls system. The international approach to food law will be introduced by exploring the timely issue of food quality. The participants will also learn more about the controversial issues of confidentiality and data-sharing in European food law (novel food, health claims regulations). The last day will be animated by the attendance of former EU Commissioner David Byrne, who will be sharing his experience at the helm of the portfolio in charge of reforming EU law in the aftermath of the BSE crisis. The academy will be completed by a challenging moot court arranged by the participants on the basis of a current case. For the detailed programme please turn to page 6-10.

■ Morning Session

An introduction to global food law

Speaker: Alberto ALEMANNO

This session aims at refreshing the knowledge of the participants in food regulation by contextualising this evolving area within the broader international framework. In particular, it will give an overview of the basic principles of food law and policy established by the World Trade Organisation and focus on some of the most recent food trade disputes. This session will touch upon:

- The relationship between national and international food law regimes
- The international level: Codex, WTO, SPS, TBT
- International food trade litigation: COOL case, Hormones II. etc.

Afternoon Session

The state of play of EU food law

Speaker: Barbara KLAUS

In this session a systematic presentation of the actual state of play of EU food law will be given notably by analysing the general principles and requirements set out by the General Food Law Regulation (EC) No 178/2002. This includes an overview on the evolution of the EU food law as well as an explanation of the following aspects:

- The application of the risk analysis and the precautionary principle in food law
- The food safety requirements
- The general requirements regarding the labelling and presentation of foodstuffs
- The responsibilities of the food business operators for the conformity of foodstuffs

■ Morning Session

The new frontiers of EU food regulation: the safety and claims of botanical and animal cloning

The speakers will compare the relevant provisions and explore the myriad of complexities concerning the development, buying, submitting, protecting and sharing of scientific data. Among other things, this includes:

- The concept of an "exclusive use" right in relation to scientific data
- Data development, access to documents, recouping investments and "free riding"
- Data sharing negotiations, Agreements and Letters of Access (LoA)
