# **Programme**

For the international KAS offices and programmes, a lot has changed since we have implemented a new management software and "digital" accounting procedures step by step not only in Asia but around the world. Partner institutions and individual contributors to our projects and activities might not need to be experts in what we call "PASTIS", yet, they are also affected, and had to be briefed in detail about the new requirements and procedures during the last two years. New accounting and planning forms, tighter deadlines and more detailed questions about each activity, a strong need for comparing offers for purchases and services etc., constitute a challenge both for KAS and its partners.

In case of our country offices and their local partner institutions, a lot of support and coaching takes place in personal contact between our staff and our local partners and contributors in the respective countries itself. In case of the regional Media Programme Asia, the adjustments had and have to be explained mostly by phone and e-mail because none of our partners resides in Singapore.

At the end of 2009, we hosted a first partner workshop to tackle organizational and quality issues. Now the time has come for a follow-up meeting concentrating on administration and planning. This time, however, we have not only invited our two long-term institutional partners ANN and ACFJ but also representatives of two emerging and promising networks, the "Society of Asian Journalists" (SAJ) and the "Political Communication Network Asia-Pacific" in order to have them join us on "the road ahead" for KAS, its regional partners and media development in Asia.
