British Prime Minister Theresa May's pledge to maintain a Common Travel Area with Ireland once Britain leaves the EU has been thrown in doubt by senior Irish Government ministers and key figures in Brussels. To read more on this story, [click here](#).

British Prime Minister Theresa May has been invited to make a historic address to the Dáil during her state visit to Ireland later this month. The statement on Brexit by British Prime Minister Theresa May has brought “clarity in a number of areas”, the Taoiseach has said. The Taoiseach insisted his Government remains in control of what is happening and accused opponents of a “blame everybody else” approach after being told he has “sat on his hands” throughout the crisis. Minister for Foreign Affairs Charlie Flanagan has warned against a “scorched earth” approach to campaigning in the Northern Ireland Assembly elections. More than half of Ireland’s households could still face domestic water charges if the expert commission’s recommendations are implemented, an Oireachtas committee has heard. The expert commission has proposed the State allow each household a free daily allowance and estimated it could be in the region of 123 litres per person per day. The head of the Irish employers' group Ibec has predicted that the UK will not be able to strike a trade deal with the EU in light of the priorities laid out this week by British Prime Minister Theresa May in her Brexit speech. This opens up the prospect of the UK switching to World Trade Organisation tariffs, which would result in significant costs being incurred by Irish exporters. New figures released today by the Central Statistics Office (CSO) show that new Irish housing supply continues to increase at a fast pace from a low level. There were 13,376 completions in the first 11 months of 2016 with the monthly total of 1,579 in November, the highest since December 2009. To read more on this story, [click here](#).

It's still "too soon" for Ryanair to make any decisions about its presence in the UK following last June's Brexit vote, according to the airline's chief financial officer, Neil Sorahan. But he said that despite announcing an expansion at Stansted Airport last week, Ryanair could reduce feed at some smaller airports in the UK or not grow as quickly there as it might otherwise have done. AIB is tipped to pay a €285m dividend within months, its first since the crash. Almost all of the money will go to the State. The money is in addition to an anticipated €3bn the State will raise by reducing its stake in the bank from more than 99.9pc through a stock market flotation. A hard Brexit would be a "double-edged sword" for Ireland according to Goodbody Stockbrokers. They warn that the impact will be dependent on both location and sector. Goodbody believe the return of customs controls will bring about significant trade frictions for Irish exporters, particularly affecting the agri-food sector. On the other hand, Goodbody claim there is now an increasing probability that financial firms will need to relocate their businesses in an EU country and this is an opportunity for Ireland, particularly Dublin. Ireland's central bank has had over 100 inquiries from UK financial firms considering moving operations as a result of Britain's vote to leave the European Union, Finance Minister Michael Noonan said on Tuesday. "The Central Bank has had in excess of 100 inquiries from the City of London from people who are anxious to find out what the regulatory regime would be here if they were to move activity," Noonan told parliament. Almost 70 per cent of Travellers live in caravans or overcrowded housing, just 1 per cent has a college degree, 82 per cent are unemployed and their health worsens more dramatically than non-Travellers as they age.
