Introduction

In many market-oriented countries, Chambers of Commerce play important roles as intermediators between private enterprises and the state. In China these kind of self-governed institutions are still in an early state of development. While a lot of non-governmental chambers of commerce have already been set up, they usually only represent a certain industry branch or are restricted to a certain city or region.

Inter-chamber coordination and internal structure still need to be improved.

Participants from Chinese and International chambers of Commerce, economists and representatives of state agencies will discuss how to improve corporate governance. The experience of different European countries will also be presented in the workshop.
