#### "A Possible IMF Pandemic Support Facility for Emerging-Market Countries"

In the <u>policy brief</u> the authors recommend that the IMF needs to adapt its strategy for pandemic situations by developing a new temporary lending instrument that primarily serves emergingmarket countries – a so-called Pandemic Support Facility (PSF). Such lending arrangements would be limited in time and scope.

With more than 6,6 million internally displaced persons in Syria, the author concludes that more comprehensive aid and support is needed.

In conclusion, the brief recommends that "any changes considered for extension should be studied to assess their long-term benefits and potential consequences."
