The EU Space Act: Boosting European autonomy in space?

The strategic and commercial importance of space is growing rapidly. What was once a domain dominated by a few national agencies is now an arena of global competition—driven by private innovation, geopolitical rivalry, and increasing security threats. For Europe, this shift presents both an opportunity and a challenge: to protect its critical space infrastructure while remaining competitive in a domain where others are moving fast.

The EU Commission has acknowledged this reality by appointing a Commissioner for Defence and Space, Andrius Kubilius, and most recently by proposing the EU Space Act. It seeks to establish a coherent European framework for space activities—improving coordination among member states, enhancing the security and resilience of space assets, and strengthening the global position of European industry. But policy coherence alone is not enough.

If Europe is to compete with major space powers, it must ensure that its regulatory environment supports innovation, incentivizes investment, and builds a secure foundation for the growing space economy. As the EU Space Act moves to the Parliament and Council for consideration, KAS Europe invites you to join us for an in-depth discussion if it this legislation is fit to boost Europe's strategic autonomy in space. This means considering Europe's long-term competitiveness, security, and technological leadership. Is the EU ready to become a credible actor in space and if so, is the EU Space Act the first step towards it?
